On the morning of 19 April 2004, Mr Taskun apprehended and disarmed an offender who had stabbed a man near Auburn Railway Station, New South Wales.

Mr Taskun was on his way to work when he saw a man with a knife chasing another man who was covered with blood. Mr Taskun ran after the two men and saw the armed man slash the victim across the chest, inflicting a wound that bled freely. As Mr Taskun neared the two men, he told the armed man to drop the knife. The offender threatened Mr Taskun and continued pursuing the victim, stabbing him in the abdomen. Fearing that the man under attack was going to be killed, Mr Taskun continued to give chase to try to stop the attack. He finally caught the armed man and grabbed him from behind, tackling him to the ground forcing him to drop the knife. Mr Taskun appealed to members of the public to assist and two men came forward and held the man down while Mr Taskun put the knife into a plastic bag. Mr Taskun gave instructions to members of the public to contact the police and ambulance and to divert traffic around the scene. He then administered first aid to the victim while waiting for emergency services to arrive.

The fire subsequently destroyed the house.

Mrs Davies only ceased rescue efforts when it became too dangerous to continue.

Unable to stay in the garage due to the intense heat and smoke, he was forced to exit the building. His clothes were on fire and he had to be hosed down. Although suffering from burns, he then attempted to fight the fire using a garden hose but was forced to withdraw when material stored in the garage started to explode. Mr Fisher later discovered that his son was not in the garage and was unharmed. Sadly, however, his nephew died in the blaze. Mr Fisher was himself badly burned and required hospitalisation.

On the morning of 24 December 2004, Mr Hines helped to disarm and restrain an offender at Matraville, New South Wales.

Mr Hines had just arrived at work at a retail store in Matraville when two male offenders entered the premises. One of the men, armed with a gun, went to the office and ordered the store owner and an employee to get down on the floor. The other offender then forced Mr Hines into the office and also ordered him down on the floor. The offenders threatened all three men in the office with the gun. One of the offenders struck Mr Hines and the other employee with a vacuum cleaner, causing a bleeding injury to the back of Mr Hines' head. During a struggle, the store owner was shot. Mr Hines and his workmate wrestled with the gunman, while the second offender fled the scene. With the assistance of a third employee who had joined them, they were able to disarm the man and restrain him until police arrived. Sadly, the store owner died from his wound.

Mr James RAWAS, deceased, Late of Maroubra NSW 2035

On the morning of 24 December 2004, Mr Rawas pursued and attempted to disarm an offender at Matraville, New South Wales.

Mr Rawas, the owner of a retail store in Matraville, was working in the office when two male offenders entered the premises. One of the men, armed with a gun, went into the office and ordered Mr Rawas and an employee to get down on the floor. The second offender forced another employee into the office and on the floor. After striking the two employees with a vacuum cleaner and threatening them with the gun, the offenders demanded the keys to the safe from Mr Rawas. On being told that Mr Rawas did not have the keys, the men tied the hands of the two employees and struck one of them again. The men continued to push and punch Mr Rawas while demanding the keys. The gun was fired and the two offenders ran from the office and out into the street. Mr Rawas grabbed a decorative machete that he kept in the office and with one of his employees, who had managed to free his tied hands, chased the offenders. While attempting to restrain the armed offender, Mr Rawas was shot. The second offender then fled. The other employee in the store had also run out as soon as he could free his hands and both employees then wrestled with the gunman, who was still trying to fire his gun. With the assistance of a third employee who arrived on the scene, they were able to disarm the man and hold him until police arrived. Sadly, Mr Rawas died from the wound inflicted.

Senior Constable David William RAYMOND, Queensland Police

On the afternoon of 6 February 2004, Senior Constable Raymond rescued a youth from floodwaters in the Mulgrave River at Goldsborough Valley, Queensland.

Senior Constable Raymond had just arrived home from work when a neighbour told him that a boy had fallen from Peets Bridge into the flooded Mulgrave River. Senior Constable Raymond advised the police communications centre of the incident as he drove to the scene in his police vehicle. When he arrived, he saw a 14-year-old boy holding on to a tree in the middle of the river about 50 metres from the bridge. Senior Constable Raymond reassured the boy, then collected ropes from his vehicle and, holding one end of the rope while people on the bridge held the other end, attempted to reach the boy by walking into the water. However, he was dragged under by the force of the flood and, unable to reach the boy, was pulled back and assisted onto the bridge. Senior Constable Raymond then returned to his home and collected his kayak, a life jacket and more rope. With the assistance of people on the bridge, he tied rope to the kayak and then paddled out to the boy. The kayak was swamped by water and capsized, but Senior Constable Raymond managed to grab hold of a tree close to the boy. He then instructed the people on the bridge to throw the life jacket attached to a rope to him. He reached across and put the life jacket on the boy who was pulled to safety. The life jacket was then thrown back to Senior Constable Raymond and he too was pulled to safety.

After delivering the man to the beach, the sailboarder returned to Ms Robertson and towed the boy the remaining 25 metres to shore, while Ms Robertson swam beside them.

He was unable to extinguish the fire and fearing an explosion, Mr and Mrs Southon moved the woman further away from the car and comforted her until ambulance and emergency services officers arrived. The car was subsequently completely incinerated.

In the early hours of 9 August 2004, five members of the Birkenbeiners Nordic Ski Club and a member of the community were involved in the rescue of three cross country skiers caught in difficulty at the summit of Mt Bogong.

The six men in this group were volunteers tasked with the rescue mission. At approximately 12.30 am, carrying heavy loads of equipment for both their own and the three skiers' survival, they began the 4 kilometre, thousand vertical metres climb to the top of Mt Bogong in darkness, in temperatures of minus 10 degrees, with winds gusting up to 80 kmph and a wind chill factor of between minus 20 and minus 40 degrees. The terrain was very steep and covered in deep snowdrifts with dangerous drop-offs on both sides of the route they took. They found the three skiers at about 4.15 am. All three were partially buried in the snow and suffering from hypothermia, with one unconscious. The rescue party worked from then until 6.00 am erecting tents; moving the unconscious skier to shelter; and administering first aid, warm drinks and food. When the weather cleared briefly at around 9.00 am, the rescued skiers were evacuated by helicopter and the rescue party descended the mountain, arriving back at their vehicles some 12 hours after setting out.
