Mr Patrick Oliphant has been the United States of America's leading political cartoonist for over 40 years. Born in Adelaide, he first worked in Australia for the *Adelaide News* for some 9 years before moving to the United States in 1964 to work for the *Denver Post* and then the *Washington Star (DC)*.

In 1967, Mr Oliphant won the prestigious Pulitzer Prize for Editorial Cartooning and in 1981 he became a fully independent cartoonist, syndicated internationally by Universal Press Syndicate. Through his cartoons, Mr Oliphant has had an immense influence particularly on the American people - their perceptions and assessments about their nation, their politics and society, about world events and about private life and individual psychology. Mr Oliphant is also an acclaimed sculptor in cast bronze and an author of numerous books and journal articles.

In 1990, the National Portrait Gallery in Washington DC held an exhibition of his cartoons, lithographs and bronze sculptures and significantly, the University of Virginia gave him an exhibition in 2009 pairing his work with that of 19th century French artist Honoré Daumier. Mr Oliphant's works are held by major collections in the United States including the Library of Congress, the Smithsonian National Portrait Gallery, Presidential libraries and many others. Additionally, he has been an active collaborator with successive Australian ambassadors to the United States of America in promoting interest in Australia and strengthening links between Australia and the United States.

Mr Oliphant has made a long-time contribution to the arts, particularly as a political cartoonist, and to strengthening bilateral relations.

Mr Donald Voelte came to Australia in 2004 as Managing Director and Chief Executive Officer of Woodside Petroleum Ltd. He retired from this position in June 2011. Under his leadership, Woodside Petroleum progressed from being a company of gas prospects to one of gas development projects.

Mr Voelte led and championed one of Australia's largest resource projects, the Pluto LNG Project which commenced production at the end of April 2012. He also significantly furthered the development prospects of the major Browse Basin gas fields, a processing plant at James Price Point in the Kimberleys. He has given energetic and passionate leadership to the LNG industry and has been a forthright contributor to public debate. Throughout his seven plus years at Woodside, Mr Voelte has been pro-Australian and pro-development, particularly in his support of employing Indigenous Australians. When he joined Woodside, the company had two Indigenous employees, there are now over 100 and increasing.

Mr Voelte also made monetary contributions, both personally and through the company, to the arts and education sectors in Perth, particularly to the University of Western Australia Business School's "Tomorrow Starts Today" campaign and to the Art Gallery of Western Australia's "TomorrowFund". Additionally, he served as a member of the Board of the University of Western Australia Business School and still serves as Managing Director and CEO of Seven West Media.

Mr Masahide (Max) Yasuda has been the President and CEO of Toyota Motor Corporation Australia since 2007. Under his leadership, Toyota has developed substantial assistance to Australia's component manufacturing industry to ensure ongoing viable automotive manufacturing in Australia. He has been committed to Toyota, to Victoria and to the automotive industry generally.

Mr Yasuda was the driving force behind the development of the Camry Hybrid car in Australia in 2009 and has relentlessly pursued Australia's interests in attracting a high technology, new engine manufacturing investment for fuel efficient and environmentally improved future generation Australian manufactured vehicles. In 2010, Mr Yasuda was appointed a member of the Commonwealth Government's Business Roundtable on Climate Change, has contributed to the Commonwealth Government's Automotive Industry Innovation Council and for the past three years he has served as Vice President of the Federal Chamber of Automotive Industries.

Additionally, Mr Yasuda has ensured that Toyota Motor Corporation Australia contributes to, and supports, a wide number of community organisations and causes. Toyota has, of course, been the major sponsor of the AFL for a number of years and has supported various other sporting teams around the nation.

Mr Yasuda has made an extensive contribution to the automotive and manufacturing industries in Australia.

Mr George Yong-Boon Yeo is Singapore's former Minister for Foreign Affairs (2004-2011), former Minister for Trade and Industry (1999-2004) and former Minister for several other portfolios. He left Parliament in May 2011. During his time in the Singapore Government, Mr Yeo made a strong contribution to the development of Singapore-Australia relations and was an important partner on a range of regional and global economic, strategic and security issues.

As Minister for Trade and Industry, Mr Yeo was integral to the negotiation and successful conclusion of the Singapore-Australia Free Trade Agreement (SAFTA) in 2003. This was the second free trade agreement Australia had concluded, the first being in 1983. SAFTA is a comprehensive agreement that has delivered greater economic integration and promoted stronger bilateral relations between Australia and Singapore.

As Minister for Foreign Affairs, Mr Yeo worked closely with Australia on efforts to counter terrorism in the region and was a strong advocate and partner for Australia at the Association of South East Asian Nations meeting, the East Asia Summit, the Asia Pacific Economic Cooperation meeting and Asia-Europe Meeting.

Mr Yeo has made a strong contribution to the Singapore-Australia bilateral relationship particularly while Minister for Trade and Industry and Minister for Foreign Affairs.

Mr Hijjas Kasturi is a well-known and respected Malaysian architect. He studied architecture in Adelaide and Melbourne, having been awarded an Australian Government scholarship under the Colombo Plan. Mr Hijjas continues his connection with Australia as a visiting lecturer at the University of Melbourne and in Adelaide. He also organises architectural exchanges for students of architecture and junior architects from Australia.

Additionally, Mr Hijjas is well-known for his contribution to the arts. Together with his wife Angela Hijjas OAM, he owns and operates 'Rimbun Dahan' - a centre dedicated to supporting the development and conservation of various art forms. The 'Rimbun Dahan' runs a range of artists' residences which also includes a fully-funded year-long Malaysia-Australia Visual Artist Residency program. Over the years, many Australian and Malaysian artists have benefitted through the artists-in-residence program.

Mr Hijjas's support of and contribution to Australian art and artists and his mentoring of Australian architecture students through student exchanges and as a visiting lecturer have had an important impact on Australia-Malaysia relations.

Mr Fram Kitagawa is Chairman of the Art Front Gallery in Japan. He is an internationally recognised art director who has worked to create bridges between art and society through his innovative arts projects. His interest in Australian art, particularly over the past 10 years, has contributed both to the high profile Australian art enjoys in Japan today and to the development of positive and mutually beneficial relationships between Australia and rural communities in Japan.

Some of Mr Kitagawa's contributions to Australia include: actively promoting Australian art as an integral part of the Echigo-Tsumari Art Triennial – a base for cultural exchange, artist and curator-in-residence programs and art exhibitions (since 2000); the touring of the Indigenous *Spirit Country* exhibition in Japan (2003); the establishment of the “Australia House” – hosting regular Artist-in-Residence Programs, as part of the Echigo-Tsumari Art Triennial (2009); inclusion of seven Australian artists in the Setouchi International Arts Festival (2010) and driving the rebuilding of “Australia House” following its destruction in one of the earthquakes that hit Japan in 2011.

Mr Kitagawa's extremely creative leadership has contributed to promoting Australian art and artists in Japan, consequently achieving a better cross-regional relationship.

Since 1998, Mr Zoran Kostovski has represented Australia as the Honorary Consul to the former Yugoslav Republic of Macedonia. As he is highly respected within diplomatic and business communities, Mr Kostovski proficiently represents Australia in official, trade and consular matters. He provides advice and information to Macedonian migration, passport and visa applicants on a daily basis, and including providing support to Australians finding themselves in difficulties in former Yugoslav Republic of Macedonia.

During official visits by Australian representatives, Mr Kostovski facilitates all arrangements for the visits, working in close consultation with the Australian Embassy. During the 1999 Kosovo conflict, when large numbers of people crossed the border from Kosovo into the former Yugoslav Republic of Macedonia, Mr Kostovski was of immeasurable help to the Embassy by offering assistance to many Australians or those with Australian connections.

As a former recipient of the Australian Program of Training for Eastern Eur-Asia (program ran from 1991 to 1997), Mr Kostovski formed strong ties with Australia which have continued into his role as Honorary Consul. He has maintained connections in government, chambers of commerce and industry, trade organisations and those responsible for human resources in business. These connections are always made available to visiting Australian business people.

Mr Yasuki Nakamura is a Board Member of the International Suzuki Association (ISA) and an Honorary President of the Suzuki Talent Education Association of Australia (STEAA). He migrated to Australia in 1979 to develop the Suzuki Method in Australia, now one of the largest Suzuki communities in the world.

Mr Nakamura has also made a strong contribution to the development of the Suzuki Method worldwide and has been very active in the work of the ISA. As President of STEAA (NSW) for 30 years (1981-2011), he guided the Association hosting three successful International Suzuki Conventions in Sydney. For the past 33 years, Mr Nakamura has dedicated his life to teaching music and to his many thousands of violin students. Every year his students are among those who win highly sought-after music scholarships to leading independent schools and who achieve outstanding success worldwide as professional musicians.

Sir Ronald Sanders is a member of the Commonwealth Eminent Persons Group (EPG) and an international consultant, writer and a former senior Caribbean diplomat (1982-1987 and 1996-2004).

Over the past 30 years, Sir Ronald has significantly contributed to expressing the concerns of the Caribbean region, particularly championing the interests of its small developing states, and the Commonwealth. During the course of his career, he has served on numerous committees and advisory boards formulating and implement policies which affect the Caribbean and the Commonwealth. Sir Ronald has been, and is, a voice for the Commonwealth and developing Caribbean states through his diplomatic work and advocacy as well as his many publications and the media.

At the Commonwealth Heads of Government Meeting (CHOGM) in November 2009, the EPG was established to undertake an examination of options for reform to bring the Commonwealth's many institutions into a stronger and more effective framework of cooperation and partnership. Sir Ronald and nine other EPG members produced the report: *A Commonwealth of the People – Time for Urgent Reform*. He was an important source of advice to the EPG on the Commonwealth as an institution and on its benefits to the governments and people of all its member states. Sir Ronald also wrote the initial draft of the report which, when finalised by the EPG, was a centrepiece of discussion at the CHOGM in Perth in October 2011.

Mr William Spooncer migrated to Australia in 1974, joining the CSIRO Meat Research Laboratory as a microbiologist. Before setting up his own company 'Kurrajong Meat Technology' in 2004, he was with Australian Meat Technology and Food Science Australia.

In 1991, Mr Spooncer initiated the first training school for personnel in the Australian rendering and allied industries. He continues to run these workshops, which are an integral part of the Rendering Industry Accreditation Program, with over 720 people having attained recognised accreditation in hygienic production of rendered animal products. Also since 1991, he has been the driving force in coordinating the Australian Renderers Association's biennial international symposia to inform and educate the industry.

During the height of the Bovine Spongiform Encephalopathy (BSE) scare (commonly known as 'mad cow disease') in the early 1990s, Mr Spooncer developed and negotiated a standard to validate the effectiveness of heat treatments in destroying pathogens in the rendering process, ensuring safe finished products. This process is now accepted as a third party audit system by importing countries. He also developed the rendering industry's Code of Practice that came into effect in 1996, which was accepted by the Government and later became the Australian Standard for the Hygienic Rendering of Animal Products. Additionally, as a member of the World Renderers Organisation's Scientific Advisory Panel, Mr Spooncer's work has been invaluable, particularly his latest contribution – the production of the 'WRO Best Practice Guidelines'.

Datuk Irene Benggon Charuruks is the General Manager of the Sabah Tourism Board since 1991. She has worked extensively to support commemorations of Australia's fallen soldiers at Sandakan, Ranau and on the Death Marches in Sabah. Over the years, Datuk Irene has assisted in the efforts toward the restoration of various memorials in Sabah including the Cleary Memorial at Ranau, Kundasang War Memorial and Gardens, the Starceovich Memorial at Beaufort and the Last POW Camp at Ranau.

Datuk Irene provides support to the annual commemorations on Anzac Day with the Dawn Service and the Sandakan Day (15 August) Service held at the Sandakan Memorial Park, as well as services in Australia commemorating the Sandakan-Ranau Death Marches. Her dedication to the memory of those who lost their lives is demonstrated through her welcoming support of veterans and their families. She has also provided tireless assistance on visits of senior Australians, including the visit of the Governor-General to Sandakan in August 2010.

Mr Desmond Cross has volunteered with many groups and organisations within his local community over a long period of time. He joined the scouting movement in 1969, serving as secretary and president of the Maitland District for many years and as a member of the area executive for 33 years. He was actively involved in fundraising and assisted with camping and transport.

In 1989, Mr Cross joined the Baden-Powell Guild, serving in a number of executive positions over a 12 year period - from deputy NSW Guild Master to Australian Guild Master. Additionally, for 27 years Mr Cross has been a member of Friends of Palliative Care, currently serving as Vice Chair.

Mr Cross's contribution to his church includes serving as an accompanist in services and conducting the church's friendship club for the past 11 years. Previously, he has been an elder, chair of the church committee, a member of the choir and a Sunday school superintendent (from 1967-1980), having also provided religious education in two schools for 12 years.

Mr Cross's other contributions include as President of the Maitland Justices of the Peace, to the local Meals on Wheels, as a volunteer in policing and as Vice Chair of the Maitland District Red Cross branch. Significantly, over the past 50 years, Mr Cross has been a very successful 'Santa' in the local community, bringing much pleasure to the young and old alike.

Mr Johan Durnez plays an important role in Belgium by keeping alive the memory of Australia's contribution and sacrifices made during the Great War. He does this through his position as a school teacher of history and over the past 15 years as a guide to visiting Australian school student groups and other visitors seeking to locate graves and cemeteries of loved ones in the Ieper area. Mr Durnez regularly attends commemorative services, particularly on Anzac Day and Remembrance Day, and produces and circulates a newsletter every two months updating on activities in the Flanders region and on school activities relating to Australia.

Mr Durnez has also made significant contributions to specific memorial projects over the years including: Geluwe in 2001, organising various commemorative ceremonies in honour of Corporal *of Horse* Leggett (2005 and 2008), the first Australian killed in the defence of Ieper in WWI; again honouring Corporal *of Horse* Leggett by assisting with the erection of a similar 'mirror' monument in Goulburn in 2005; and organising and assisting Australian school student groups in organising various commemorative services in Harlebeke for a young Aboriginal soldier from South Australia, Rufus Rigney (from 2004 to 2008 and in 2010).

Mr Durnez ensures that Australian sacrifices in Belgium during WWI continue to be remembered and the people who died there continue to be honoured.

Dr Hans-Ullrich Henschel, a paediatrician by profession, is the founder and President of *flydoc australia e.v. (Inc)*. He established this charitable association as a support group for Australia's Royal Flying Doctor Service (RFDS) in Germany in 2004.

Flydoc australia's main objective is to collect donations for the RFDS in Germany. To this end, Dr Henschel organises a range of fundraising activities which often generate valuable publicity for the RFDS and for Australia in general. He regularly travels to Australia, personally visiting a large number of RFDS bases to present donations and to offer support and encouragement to RFDS staff across the country. Since its establishment, *flydoc australia* has raised approximately \$110,000. Additionally, in response to the devastation caused by Cyclone Yasi in February 2011, Dr Henschel initiated a fundraising campaign to assist those in the affected areas of Queensland.

Dr Henschel spends a lot of time promoting the RFDS; regularly speaking to students in Germany to encourage their fundraising efforts and also by establishing a *flydoc australia* website in German. Through his initiative, Dr Henschel has raised awareness in Germany of a unique Australian institution, the RFDS, and also created a wider interest in the more remote parts of Australia.

Mrs Nellie Morgan is an active member of the Dee Why community in Sydney - volunteering with Meals on Wheels and as a qualified teacher of Scottish country dancing.

Although aged in her 90s and with failing eyesight, Mrs Morgan volunteers three days a fortnight delivering meals to the sick and elderly. She arrives early, checks all the deliveries and then is off on the road, with her driver, distributing meals. Mrs Morgan has volunteered with Meals on Wheels for the past 20 years.

Additionally, Mrs Morgan teaches Scottish dancing for two hours every week in Dee Why. Her enthusiasm for dancing is contagious with the classes always ending with a cuppa and a chat – a very social engagement for her dance students. Until a few years ago, Mrs Morgan also danced and taught dance for decades at the Cremorne/Neutral Bay area, and often served as the driver, transporting dancers to various performances. Overall, for a period of some 25 years, she conducted two adult weekly dance classes and also in-school dance lessons for children.

Mrs Morgan is a remarkable woman who enjoys dancing and takes great pleasure in teaching others. Her volunteering with Meals on Wheels is also commendable.
