BRAVERY MEDAL

On 13 December 1979 at about 10.30 p.m. a man of heavy build fell from an overhead walkway at Homebush Railway Station, New South Wales, on to the railway lines below. He was rendered unconscious by the fall. Mr Alderton, then employed at the Homebush Railway Station as a Station Assistant, a slightly built man, aged 19 years jumped down to the railway lines to rescue him. Notwithstanding the fact that he then observed a through train travelling at speed just entering the Station, he succeeded in performing the almost impossible task of lifting the man up on to the platform with no time to spare. Mr Alderton then dived on to the platform and held the man's leg which was hanging over its edge to keep him free of the train.

His actions in such hazardous circumstances saved the man from death or serious injury.

Both men grappled with the firearm until bank staff were able to assist Mr Yates in overpowering the offender.

Station Officer Cronin, and another Brigade Officer, donning compressed air breathing apparatus, searched for approximately one hour underwater in a large sump area some 4½ metres below the bottom of the fountain until the boy was located in an air pocket about 4 metres inside a branch tunnel. They then dragged him out of the tunnel and assisted him to the surface.

COMMENDATION FOR BRAVE CONDUCT

On 26 October 1979 at about 5.30 p.m. a fire occurred in the laundry/toilet section of the home occupied by the McEwan family at Wembley Downs, Western Australia. Anthony's step-mother, who was trapped in that part of the house, called for help. Anthony, aged 15 years, wearing light clothing and without footwear ran through the flames and despite being badly burned as a result, broke a window and assisted his step-mother to safety.

Anthony Mc Ewan displayed commendable courage in such circumstances.
