

## STAR OF COURAGE

### **Dr Lee Nigel GORDON-BROWN, Montrose Vic 3765**

On the morning of 21 October 2002, Dr Gordon-Brown assisted in overpowering and restraining a man who had just shot dead two students and wounded five other people during a lecture at Monash University.

Dr Gordon-Brown was conducting a regular Monday morning Commerce honours class with about 15 students when one of the students used a handgun to spray a volley of shots around the room. Dr Gordon-Brown was shot twice and fell to the ground. During a pause in the shooting, Dr Gordon-Brown saw the gunman lower his arms and rummage inside his jacket. Believing him to be preparing to reload his gun, Dr Gordon-Brown, although in pain and increasingly weak from blood loss, ran at the gunman and held him around the waist while instructing another man to seize the gunman's shoulders and arms. At some stage during this, the offender dropped the handgun. Despite his injuries, Dr Gordon-Brown continued to hold the offender's legs until another man was able to relieve him.

By his actions, Dr Gordon-Brown displayed conspicuous courage.

### **Mr Colin Jeremy SUTTON, deceased, late of Golden Grove SA 5125**

On the afternoon of 16 June 2001, Mr Sutton attempted to close off a leaking gas valve to try to prevent an explosion at the Santos gas plant in Moomba, South Australia.

Mr Sutton was working as a process operator in the pumping shed at the gas plant testing a pump that was undergoing maintenance when flammable liquid began pouring through the top of the pump and hit the ceiling. Mr Sutton immediately rushed to try to close off the leaking valve. As he did so, he was showered in the liquid material. He left the shed to alert others to the situation, then re-entered the shed alone and again attempted to close the valve. He became completely covered in the liquid material and left the shed again briefly to have his face wiped. Without hesitation, he re-entered the shed a second time and continued his efforts to close the valve. Instantaneously, there was an explosion and the shed was engulfed in flames. The fire within the shed was subsequently extinguished, and Mr Sutton was found wedged between two pipes having suffered extensive burns to his body. Tragically, Mr Sutton later died from his injuries.

By his actions, Mr Sutton displayed conspicuous courage, thereby losing his life.

## STAR OF COURAGE

**Mr Ronald James WALL**, 43 Gleeson Crescent, Toowoomba Qld 4350

On the afternoon of 28 February 2004, Mr Wall rescued a woman and child trapped in a burning vehicle after a collision at Berrinba, Queensland.

Mr Wall was driving on the Logan Motorway when he stopped to assist at the scene of a three-vehicle collision. Mr Wall ran to one of the vehicles, which had rolled over and was on fire. The injured female driver was trapped unconscious in her seat and an injured unconscious child was trapped in the rear seat of the vehicle. Mr Wall climbed on top of the vehicle and forced the rear door open. While another man held the door, Mr Wall lowered himself into the burning vehicle, released the child's seatbelt and lifted the child out of the vehicle into the care of others. Despite the increasing danger from the fire and the intensity of the heat and smoke, Mr Wall returned inside the car, slid into the front seat, and, after several attempts, freed the woman's trapped foot. He then lifted her up high enough for people outside the car to carry her to safety. Mr Wall was overcome with shock and exhaustion and needed to be assisted from the vehicle.

## **BRAVERY MEDAL**

### **Sergeant Peter Leslie ANDERSON, Victoria Police**

On the morning of 28 November 1998, Sergeant Anderson rescued a girl being held captive by a male offender in a mineshaft at Black Hill Reserve, Ballarat.

Sergeant Anderson, a member of the Victoria Police, was on duty as part of a team investigating the disappearance of a sixteen-year-old girl in the Ballarat area. The investigating officers believed the girl had been abducted by a notorious offender, and went to investigate if the victim was being held captive in a dangerous mineshaft at the Black Hill Reserve. Sergeant Anderson descended alone into the narrow mineshaft, and crawled over rocks and through narrow openings, mostly in total darkness, for nearly 70 metres. Along the way he observed a number of objects that led him to believe the girl was being held in the mineshaft and feared she may be already dead. Eventually he located and identified the offender and the missing girl. He subdued and handcuffed the man so that the girl could be led to safety.

By his actions, Sergeant Anderson displayed considerable bravery.

While holding the gunman, Mr Boast called for security, police and an ambulance and, at the same time, attempted to help two of the wounded remain conscious by keeping them talking.

**Mr Martyn Andrew CARNE**, 11 Tipperary Avenue, Killarney Heights NSW 2087

On the evening of 13 October 2002, Mr Carne helped rescue a man from a burning aircraft at Bungendore, New South Wales.

Mr Carne was at home when he saw a light plane that appeared to be in trouble. He and his wife drove out to investigate and when they saw black smoke realised the plane had crashed. They arrived at the crash site along with several neighbours. They found the front of the plane on fire and petrol running down the underside of one wing and dripping onto the two male occupants. One of the men had been severely burned and appeared to be dead. The second man, the pilot, was bleeding profusely from a gash on his head and was engulfed in flames to his waist. Mr Carne, with the help of two neighbours, lifted the pilot and pulled him away from the plane, which was now burning intensely. Mr Carne and a neighbour comforted the pilot and administered first aid until the arrival of the ambulance. Sadly, both men died from their injuries.

After reassuring him, Mr Chester cut the boy's school bag free and then, cradling the boy to his chest, pulled him from under the train to safety. The boy was subsequently treated for fractures to his femur and pelvis.

On the morning of 3 April 2003, Miss Cramp went to the assistance of a fellow school student at Tomaree High School, New South Wales, who had been shot in the chest with a crossbow and remained with the victim to provide aid despite continued threats of harm by the offender.

Miss Cramp was in the schoolyard when she saw a female student stagger around the corner of a building holding her chest. The student, who had been shot in the chest with a crossbow, slumped onto a bench and Miss Cramp noticed blood on her chest and under her hand. Miss Cramp went immediately to her aid. She applied pressure to the wound and talked to the student. Although most other witnesses had backed away from the situation, Miss Cramp stayed and was with the victim when the offender threw a lighted Molotov cocktail at them. The bomb smashed at their feet and Miss Cramp was splashed with kerosene, but fortunately the fuel did not ignite. Miss Cramp stayed with the victim, providing first aid and comfort with the assistance of others, while the offender was tackled and restrained, and until an ambulance arrived.

### **Mr Paul Gerald DARMODY, "Wynella", Bungendore NSW 2621**

On the evening of 13 October 2002, Mr Darmody helped rescue a man from a burning aircraft at Bungendore, New South Wales.

Mr Darmody was working on his farm when he saw a light plane crash on a neighbouring property. He alerted a couple who lived nearby, then drove to the crash site, where several neighbours joined him. Mr Darmody and his neighbours found the front of the plane on fire with petrol running down the underside of one wing and dripping onto the two male occupants. One of the men had been severely burned and appeared to be dead. The second man, the pilot, was bleeding profusely from a gash on his head and was engulfed in flames to his waist. Mr Darmody, with the help of two neighbours, lifted the pilot and pulled him a few metres from the plane, which was now burning intensely. Mr Darmody returned to the plane to see if he could help the passenger; however the man was dead. Sadly, the pilot also later died from his injuries.

### **Mr Milton Wayne ELLIS, 29 Fairy Street, Moorooka Qld 4105**

On the afternoon of 22 December 2003, Mr Ellis assisted in the rescue of two men from floodwaters after a crocodile attack in the Finnis River, Northern Territory.

Mr Ellis was working as a helicopter engineer and crewman as part of a response team tasked with rescuing two men who had taken refuge in a large tree surrounded by rising floodwaters after their friend had been taken by a 4 metre crocodile. Despite rain squalls, poor visibility, flood conditions and the potentially still-present danger of the crocodile, Mr Ellis and another man were winched, with a life raft, down from a helicopter slightly upstream from the tree where the two men were trapped. Mr Ellis and the other man set off in the raft using swim fins, a water tray and broken branches as paddles. The helicopter pilot positioned the aircraft to enable the downdraft to push the raft against the current and assist Mr Ellis and the other man to paddle across the river, a method that also increased the risk of overturning the raft. Mr Ellis and the other man managed to reach the tree and convinced the two trapped men to jump into the raft. Eventually they made their way back safely to the riverbank. Sadly, no sign was found of the man taken by the crocodile.

**Mr Clinton James HAWES**, 73 Rawson Street, Aberdare NSW 2325

On the afternoon of 21 April 2003, Mr Hawes helped rescued an elderly woman from a house fire at Cessnock, New South Wales.

Mr Hawes was visiting his girlfriend when he noticed flames coming from a neighbour's house. He rang 000 and then ran to the neighbour's house and called out to the elderly female occupant. Mr Hawes kicked the front door open and, with another man, crawled into the house. The two men were forced to retreat because of thick black smoke and intense heat but Mr Hawes re-entered the house and heard the woman say that she could not breathe or move. He crawled along the hallway but was again driven from the house by the smoke and flames. Despite suffering from smoke inhalation he re-entered the house, which was now almost completely engulfed in flames, to assist another man to drag the woman to the front door where bystanders helped by moving her to a safe distance from the house. Sadly, the woman later died from her injuries.

On the morning of 17 March 2004, Mr Johnson rescued an elderly woman from a burning house at Karalee, Queensland.

Mr Johnson was in his backyard when he smelt burning plastic and saw grey smoke billowing from his neighbour's roof. Mr Johnson ran to the burning house to check on the elderly female occupant, and found another man there who was also concerned for the woman's safety. After forcing open a locked back door, Mr Johnson and the other man tried several times to enter the house but were driven back by thick black smoke. They also tried to encourage the woman to crawl to the door, but she replied that she was trapped. While the other man continued to attempt to find the woman from the rear of the house, Mr Johnson smashed a window at the front of the house, crawled into the house and located the woman sitting on her bed. He pulled her across to the window and lay down on the broken glass so that the other man could pull her out over his body without her being cut by the glass. The woman was carried a safe distance from the house until the ambulance and fire service arrived. The house was completely destroyed by the fire.

### **Acting Sergeant Paul Francis McGIRR, New South Wales Police**

Early in the morning of 4 April 2002, Constable McGirr helped rescue residents trapped in a burning block of units at Wiley Park, New South Wales.

Constable McGirr, as a member of the New South Wales Police, was on duty when he was alerted to a fire at a block of home units. He and three other police officers arrived at the scene and were informed that there were people inside a unit that was well alight. The police officers entered the building and proceeded up the stairwell through thick smoke. Two of the police officers broke down the front door of the unit and, as the fire spread through the unit, dragged a female occupant from her bed and into the corridor. Constable McGirr and a colleague took hold of her and pulled her to the front of the building. With the roof of the building collapsing, the four officers then carried the woman from the building to safety. After being advised that there were still people in the building, the police officers re-entered and in spite of considerable danger from burning ceilings and smoke, broke down the doors of each unit and hurriedly evacuated all residents safely from both levels. Constable McGirr and another officer carried children from the building.

On the night of 25 July 2003, Constable McIntire helped rescue two people from a burning house at Queanbeyan, New South Wales.

Constable McIntire, a member of the New South Wales Police, was on duty when he and another police officer were called to a house fire. Two other officers were also in attendance. Constable McIntire looked through a window and saw a man and a woman asleep inside the house. He broke the window, which was covered in a metal security grille, and shouted to the occupants to get out as the house was on fire. The two people seemed unaware of the danger and proceeded to pack belongings. Constable McIntire and his colleague ran to the front door, kicked it in and entered the house accompanied by two other officers. The four officers attempted several times to reach the room where the occupants were located, but were forced back outside by the thick black smoke and toxic fumes. By this time the fire had spread and the roof had begun to collapse. Eventually the woman made her way out of the room and Constable McIntire and another officer dragged her from the house. Constable McIntire and two other officers made several more attempts to enter the house. Eventually Constable McIntire was able to get to the front room where he took hold of the man and dragged him outside. The four police officers secured the area after determining there were no other occupants in the house. After a short time the whole house was engulfed in flames.

### **Sergeant Glenn James McPHEE, Northern Territory Police**

On the afternoon of 22 December 2003, Sergeant McPhee assisted in the rescue of two men from floodwaters after a crocodile attack in the Finniss River, Northern Territory.

Sergeant McPhee, a member of the Northern Territory Police, was on duty as part of a response team tasked with rescuing two men who had taken refuge in a large tree surrounded by rising floodwaters after their friend had been taken by a 4 metre crocodile. Sergeant McPhee and another man were winched, with a life raft, down from a helicopter slightly upstream from the tree where the two men were trapped. ### **Constable Thomas David O'BRIEN, New South Wales Police**

Early in the morning of 4 April 2002, Constable O'Brien helped rescue residents trapped in a burning block of units at Wiley Park, New South Wales.

On the morning of 3 April 2003 Mr Pettit tackled and restrained an offender who had fired a crossbow and thrown a Molotov cocktail at fellow students at Tomaree High School, New South Wales.

Mr Pettit was playing handball in the grounds of the school when he heard a scream, went to investigate and saw a female student sitting on a bench holding a bloodstained jumper to her chest. He then saw a male student ignite and throw a Molotov cocktail at the victim and other students who had gone to help her. The bottle smashed against a wall but failed to explode. Mr Pettit saw the male student take another bottle from his backpack and attempt to ignite it with a cigarette lighter. Mr Pettit ran at the offender and grabbed him from behind. While the offender attempted to burn Mr Pettit with the cigarette lighter, Mr Pettit put him in a headlock and struggled to restrain him. Other students came to assist him and together they were able to hold the offender until a teacher took him away. Mr Pettit then went to comfort a second female student who had been injured by the crossbow.

### **Sergeant Wayne Morris PINNER, Victoria Police**

On the afternoon of 10 January 2004, Sergeant Pinner rescued a woman from the Goulburn River near Seymour, Victoria.

Sergeant Pinner, a member of the Victoria Police, was on duty when he responded to a call advising that a woman had jumped into the river from a disused bridge. When he arrived at the scene, Sergeant Pinner heard the woman crying out for help and saw her struggling in the water. He immediately removed his uniform, dived into the river and swam about 50 metres to reach the woman who was now at the point of exhaustion. Sergeant Pinner grabbed the woman and struggled to get her ashore. The river was swollen and flowing fast and the water temperature very low. The woman twice slipped from his grasp. Despite the strong current sweeping them downstream, he was eventually able to pull the woman safely to the riverbank, where he administered first aid and, with the assistance of other police officers, took her to a location where an ambulance could safely reach her.

Mr Sarraf confronted and briefly struggled with the offender who was still armed. The offender fled and, after checking on the condition of his father, Mr Sarraf gave chase, followed by his cousin. Mr Sarraf caught up with the offender some distance away, tackled him and, after having the gun pointed directly at him several times during the struggle, succeeded in disarming the man. While the offender continued to threaten them, Mr Sarraf and his cousin wrestled with him and were able to detain him until police arrived. Sadly, Mr Sarraf's father died from his injuries.

On the evening of 17 August 2004, Mr Zanoni rescued a man from the surf at Ocean Grove, Victoria.

Mr Zanoni was going for a run on the beach when he heard a man calling for help. Two fishermen had been thrown from their boat after it was swamped by waves; one of the men managed to hold onto the boat while the other disappeared beneath the surface. Mr Zanoni immediately returned to his house and asked his housemate to accompany him and help the stranded fisherman. Despite rough seas, freezing conditions and poor visibility, Mr Zanoni and his friend paddled their surfboards out to help the man clinging to the boat. They encouraged the man to let go of the boat and climb onto a surfboard. They then paddled back towards the shore. Once they were close to the shoreline, another male entered the water and helped carry the victim to safety. Sadly, the other fisherman drowned in the incident.

On the evening of 19 September 1996, members of the Queensland Fire Service attempted to rescue a small child who had fallen from a ferry terminal into the Brisbane River at St Lucia, Queensland.

When the group responded to the call, visibility above water was already very limited due to darkness, and visibility below water was almost non-existent. The strength of the current and depth of the water also made searching very difficult. Mr Ovey and Mr Campbell entered the water without breathing apparatus but were unsuccessful in their search and left the water. The members of the group subsequently donned compressed air breathing apparatus and searched the water for some forty-five minutes, despite having no protective clothing and having had no training or experience in using breathing apparatus underwater. When the search was finally abandoned, the men required medical assistance for exposure. Sadly, the child drowned in the incident.

On the afternoon of 18 January 2003 severe bushfires accelerated by extreme weather conditions encroached on urban areas of Canberra causing the deaths of four people; the loss of almost 500 homes and 93 community, commercial and farm buildings; damage to many other homes and businesses; major disruption to the city's infrastructure; and widespread destruction of forests and the environment.

A State of Emergency was declared in the early afternoon. At the height of the firestorm members of the group worked in the Weston Creek area where the fires had the greatest impact, particularly in the suburbs of Chapman, Duffy, Rivett and Holder. They worked with other fire, police and ambulance service personnel under extremely dangerous conditions and at great personal risk to protect lives and property by evacuating residents, directing anxious and distressed people to safety, providing medical aid and, in some cases, entering burning buildings to ensure residents had evacuated safely. The members of the group were exposed to huge walls of flames being fuelled by nearby pine forests and strong winds, exploding gas lines and cylinders, falling power poles, and burning trees. Intense smoke limited their vision and made breathing difficult. Their efforts continued well into the night.

On the morning of 9 September 2004 a bomb exploded some four metres from the front gates of the Australian Embassy in Jakarta, killing eleven people and causing considerable damage to the Embassy and its grounds.

In the immediate aftermath of the explosion, when it was widely believed that there was still the possibility of further explosions and when the extent of damage to the building was unknown, a number of Embassy personnel, both Australian citizens on posting and locally engaged staff, put aside concerns for their own safety and acted to ensure the safety of others and to secure the site against further attack. Some who were on-site went immediately to the front of the Embassy compound and stayed there to help the injured; others who were off-site made a deliberate decision to go from a place of safety to the Embassy compound to provide assistance, and others stayed inside the potentially unstable building to evacuate others before themselves.
