## Part 1—Preliminary

### 1 Name

This instrument is the *National Medal (Approved Voluntary Organisations) Determination 2025*.

### 2 Commencement

- (1) Each provision of this instrument specified in column 1 of the table commences, or is taken to have commenced, in accordance with column 2 of the table. Any other statement in column 2 has effect according to its terms.

### 3 Authority

This instrument is made under subregulation 9(1) of the *National Medal Regulations 2011*:

- (a) set out in the Schedule to the Letters Patent dated 20 April 2011 given under the Great Seal of Australia; and
- (b) as amended by the Schedule to the Letters Patent dated 29 January 2020.

### 4 Schedules

Each instrument that is specified in a Schedule to this instrument is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this instrument has effect according to its terms.

### 5 Definitions

- (1) In this instrument:

**Patrol Member** means an Active Member of Surf Life Saving Australia Limited (including a Life Member, Reserve Active Member, Long Service Member or Past Active Member) who:

- (a) has met the requirements for the annual proficiency test for the Surf Life Saving Australia Limited Bronze Medallion for each year of eligible service; and
- (b) has completed at least 30 patrol hours in each year of eligible service.

**Regulations** means the *National Medal Regulations 2011*:

- (a) set out in the Schedule to the Letters Patent dated 20 April 2011 given under the Great Seal of Australia; and
  - (b) as amended by the Schedule to the Letters Patent dated 29 January 2020.
- (2) Expressions used in this instrument have the same meaning as in the Regulations.

## Part 2—Approved voluntary organisations

### 6 Approved voluntary organisations, approval dates and eligible service

(1) For the purposes of subregulation 9(1) of the Regulations, a voluntary organisation specified in column 1 of an item of the following table is an approved voluntary organisation.

- (2) The approval date for the organisation is the date specified in column 2 of the item of the table in subsection (1).
- (3) For the purposes of subregulation 18(4) of the Regulations, the first day of service in the organisation that can be counted as eligible service is the day specified in column 3 of the item of the table in subsection (1).



(4) However:

- (a) the references in item 4 of the table in subsection (1) to persons who perform functions do not include a reference to a person performing functions in any of the following capacities:
  - (i) General Member;
  - (ii) Associate Member;
  - (iii) Probationary Member;
  - (iv) Award Member;
  - (v) Cadet Member;
  - (vi) Junior Activity Member;
  - (vii) Honorary Member; and
- (b) the references in item 5 of the table in subsection (1) to persons who perform functions do not include a reference to a person performing functions in any of the following capacities:
  - (i) organisational or auxiliary member;
  - (ii) radio operator;
  - (iii) first aid officer for community events.

Note: In subparagraph (b)(i), organisational or auxiliary member includes members engaged in supervisory, management, organisational or training roles.
